VII. Welcome, Opening Remarks
a. Sheila Briggs

Sheila Briggs welcomed members and laid out their plans to further discuss as a committee the work around career pathways, academic and career planning, and apprenticeship. She turned it over to Sharon, Robin, and Karin to talk about the New Skills for Youth grants, high skill high demand pathways, etc.

a. Career Pathways

The group shared about differences between pathways, they can be local or regional, and how the pathway can be created. Karin talked about the need for embracing regional pathways and opportunities for members, not just pockets of excellence for some. Dave Brukaradt asked about balancing regional outreaches and statewide rollouts. Sheila responded that they wanted to maximize people's time without replicating work already done at other levels, going beyond pockets of excellence to statewide excellence and access to all. Bruce Palzkill shared about a recent submission request for \$5M DOL grant to focus on youth apprenticeship, as well as other federal apprenticeship grants. The group discussed what recommendations would look like, including fully funding regional career pathways, expanding apprenticeship opportunities, etc. The group made a motion to support that

Sheila take the career pathways program recommendation to the Exec Committee, with full support of this committee. Sara Rogers amended the ask to ask that it include the Tools of the Trade. The amended motion carried.
